If a horse is co-owned, then at least one owner must either be a MHSA member or sign a MHSA Hold Harmless Agreement Form. Name changes during the year are subject to a \$1.00 fee and a new registration. If any of the above registration requirements are not met, year-end points will not be awarded.
